Booth moved, seconded by Berney appoint Alvin Grewe, Thomas McVeigh, and Raymond Baker on the Board of Review. All Ayes. Motion Passed.

Avery moved, seconded by Buchanan to approve the Fire Department Policies number #101, #113, #115, and #116. All Ayes. Motion Passed.

REPORTS:

Treasurer's report was accepted. Savings \$75,574.84, Checking \$2,038.86, Cemetery \$966.83, Fire Checking \$600.31, Fire Savings \$16,216.81, Parks \$3,469.54, Roads \$53,412.06. Total \$152,279.25.

Fire Report: Fire Chief Kelly Smith gave fire Report. Firemen have an invitation to attend an aircraft crash training session at the Alpena airbase.

Assessor report consisted of approving one land division and working on new assessment roll. Board of Review met in December.

ISSUES DISCUSSED:

Township snowplow bid from Mio Fence Co. was the only one. The bid was \$50.00 for township hall and \$40.00 for Luzerne Fire Station each plow. Dirk Knepp will continue to plow the Mio sidewalk.
