TREASURER'S REPORT: Half of the State contribution to the dam park came in (\$52,500), Mio School paid for summer tax collection, Fire Dept. sold parts from old tanker for scrap bringing in almost \$3000. Fund balances as of Aug. 20, 2013: General Fund - \$151,747.53; Cemetery - \$13,398.57; Parks - \$120,125.90; Roads - \$169,806.58; Fire Millage - \$143,580.72; Luzerne VFD - \$52,621.05.

FIRE REPORT: Reported on Fire Dept. activities including 2 fires, one accident, and a public relations activity.

ASSESSOR'S REPORT: Turned in July Bd. Of Review paperwork.

COMMITTEE REPORTS: BCMUA – Received \$5000 grant from insurance co. to buy video equipment for viewing sewer mains; entered a contract with an engineering firm for grant application for capital improvement plan.

Tri-Town – Should be receiving \$2500 from DNR soon to reimburse for last year's foam purchases.

In 2012 the Board attempted to update the blight ordinance as a civil infraction ordinance but the public attending the ordinance workshop was not interested in the township supervisor having that much authority, so the process was dropped.

Recommended by meeting attendees that the ordinance be changed to a civil infraction ordinance so enforcement will be less complicated.

Review of blight/junk ordinance will be on next month's agenda for updating and review.
