TREASURER'S REPORT:

Tax collection completed and taxes moved to general fund. Fund balances: General Fund - \$237,677.08; Cemetery - \$12,514.31; Parks -\$4,391.08; Road Fund - \$147,497.38; Luzenre Fire Fund - \$16,3256.41; Fire Millage - \$241,600.01.

FIRE REPORT:

Fire personnel responded to two accidents and downed power line and attended hazmat training at Tri-town Fire Dept.

ASSESSOR REPORT:

Assessment roll turned in to county; taxable value for the Township is \$106,000,000.

COMMITTEE REPORTS:

MTA met last night (April 14), discussed millages proposed by county.

Utility authority adopted budget for year.

Tri-Town adopted budget for year.

OLD BUSINESS:

AA use of fire hall – Fire personnel do use the hall when a meeting is in progress; there's never been a problem with the AA personnel. Core group of 4-6 people attend the meetings regularly. Meet 4 times weekly, twice in mornings and twice in evenings. Rent is being paid to Luzerne Firefighters' Assn.

McGregor/Avery to allow AA to continue to use the Luzerne Fire Dept. building for the 4 scheduled meetings weekly and the rent donation will be payable to the Township. All ayes. Motion carried.

Blight Ordinance – Booth recommended subsequent violation be within 24 months. Also, the enforcement should be "by a designee of the Township Board."

Those changes will be made in the proposed ordinance.

Mitchell/McGregor to send proposed blight ordinance to attorney for review and address at May meeting (if returned by attorney). All ayes. Motion carried.

Committee for dangerous buildings – McGregor/Mitchell/Roddy/L. Lange volunteered to be on a committee to update our dangerous buildings ordinance.
